

# October 2007/September 2008 Annual EEO Public File Report for Radio Station KWSO(FM), Warm Springs, Oregon (Prepared October 2008)

The purpose of this EEO Public File Report (*Report*) is to comply with § 73.2080(c)(6) of the FCC's Rules and Regulations. This Report covers the Station Employment Unit comprising noncommercial educational radio station KWSO(FM), Channel 220C2, Warm Springs, Oregon, FCC Facility ID No. 13582 (the *Station*).

### **Section 3: Supplemental (Non-Vacancy-Specific) Recruitment Activities Undertaken By the Station**

1. In conjunction with the Warm Springs Work Force Development Department, KWSO conducted a summer internship program for high school students as interns to expose them to broadcasting as a career. Each intern gained experience in performing functions around the radio station.

2. KWSO engages on an ongoing basis in on-the-job training of its staff. Much of the staff is drawn from the Warm Springs Reservation, and many start their broadcasting careers by taking entry-level positions. We employ orientations and ongoing coaching and training to help hires develop their talents and to take on increasingly responsible duties and positions.

3. It is the policy of the Confederated Tribes of the Warm Springs Reservation of Oregon to hire individuals solely upon the basis of their qualifications for the job to be filled and not to engage in unlawful employment discrimination. Further, it is the intent of the organization to give preference in employment and career opportunity to members of the Confederated Tribes of the Warm Springs Reservation of Oregon. Therefore, all other things being equal, tribal members will be considered first to fill vacant positions. The Confederated tribes will promote tribal-member employment by giving preference to those applicants who are tribal members, provided they meet the minimum qualifications needed to either fill the vacant position or participate in an Affirmative Action training plan.

If there are multiple applicants for a position, and all applicants have similar qualifications, preference in hiring is given in the following order:

- I. Tribal Member of the Confederated Tribes of the Warm Springs Reservation of Oregon
- II. Married Into the Confederated Tribes of the Warm Springs Reservation of Oregon
- III. Native American - not a member of the Confederated Tribes of the Warm Springs Reservation of Oregon
